Part V - Cancellation and Refund Policy

Should a student's enrollment be terminated or cancelled for any reason, all refunds will be made according to the following refund schedule:

- Cancellation requires the submission of a Cancellation Notice (Form 108) by electronic mail to info@usnannyinstitute.com or by termination. Form 108 can be found in the student portal.
- If the US Nanny Institute does not accept the student or the student does not start any classes and cancels within (3) business days after making payment, 100% of fees and tuition (less the \$50 nonrefundable enrollment fee) will be refunded.
- Cancellation after enrollment through 25% of the program as determined by courses completed and/or time allocated will result in a Pro Rata refund. The refund is computed on the number of hours completed to the total program hours and/or the number of days since enrollment to the total number of days allocated to complete the program.
- Cancelling after completing more than 25% of the program (courses and/or time allocated) will result in no refund.

- Refunds will be made within 30 days of termination of student's enrollment or receipt of Cancellation Notice (Form 108) from the student.

Part VI – Important Information

Grounds for Termination

I agree to comply with the rules and policies and understand that the US Nanny Institute shall have the right to terminate this contract and my enrollment at any time for violation of rules and policies as outlined in the Course Catalog and Policies. I understand that the US Nanny Institute reserves the right to modify the rules and regulation, and that I will be advised of any and all modifications.

Graduation Requirements

I understand that in order to graduate from the program and to receive the certification, I must successfully complete the required number of scheduled clock hours as specified in the catalog and on the Student Enrollment Agreement, pass all written and verbal assignments, pass proficiency exams with at least an 80%, and satisfy all financial obligations to the US Nanny Institute.

Placement Services

I understand that the US Nanny Institute has not made and will not make any guarantees of employment or salary upon my graduation. The US Nanny Institute will provide me with placement assistance, which will consist of online courses that identify employment opportunities and advise me on appropriate means of attempting to realize these opportunities.

Waiver of Liability

I hereby release, discharge, and agree to hold harmless Amslee, LLC and the US Nanny Institute, its trustees, agents, employees, representatives and volunteers, from any and all liability arising out of or in connection with my participation in the Childcare programs and/or job placement services. For purposes of this Release, liability means all claims, demands, losses, causes of action, suits or judgments or any kind that I or my heirs, executors, administrators, and assigns may have against the Amslee LLC or the US Nanny Institute, its trustees agents, employees, representatives and volunteers, because of a failure to pass any course or class or obtain any particular grades, personal injury, accident, illness, or death or because of any loss or damage to property that occurs to a person including me or to my property during the Childcare program and that results from any cause including but not limited to the passive or active negligence or other acts of Amslee LLC or the US Nanny Institute, its trustees, agents, employees, representatives and volunteers, other than fraud, willful misconduct, or a knowing violation of the law.

Indemnification
